## AGREEMENT FOR THE SUPPLY OF WATER AND/OR ELECTRICITY

### GENERAL INFORMATION

1. Private persons must present a copy of their identity document.
2. If signed on behalf of another legal person, authorization thereto must be attached to this agreement.
3. In case of a new building, supply will not be connected if the electrical wiring has not been approved by the electrical department.
4. In case of a new connection a quotation of the electrical department must be attached.
5. In case of a tenant, the owner **must** complete section "E".
6. Complete the agreement in print and delete whichever is not applicable.

### APPLICATION FOR SERVICE

I, the undersigned, the owner/owner's principal/tenant hereby apply for the supply of water and/or electricity on the property as from the date mentioned hereunder and accept the conditions set out in the water and electricity By-laws of the Municipality and take notice that my deposit or any balance thereof will be confiscated should I not apply for a refund thereof within one year after termination of this agreement.

Should I/we fail to comply with my/our obligations in terms of this agreement, necessitating the Municipality to institute legal action against me/us, I/we shall be liable for payment of all legal costs incurred by the Municipality to the scale as between Attorney-and-own client including collection commission.
